REGISTRATION FOR SARASOTA COUNTY ATTORNEY TAX TO FUND LAW LIBRARY

Pursuant to Florida law, all information provided is a public record.

The Sarasota County Attorney Tax is to be paid by persons licensed as members of the Florida Bar residing and practicing law, or maintaining an office, in Sarasota County. The fee is \$25.00 annually, and the tax is used to fund the Sarasota County Law Library.

After the registration is processed, if payment is not included, someone will contact you. The annual tax may be paid at www.SarasotaTaxCollector.com, by mail, or in person. Bills are emailed or mailed in August. The easiest and quickest way to pay is online, and no password or registration is required.
